Pay a one-time \$100 initial fee, which is non-refu	ındable.	
1. Members must be 18 years of age or older.		
2. Members must not have been convicted of a	monetary, violent or sexual crime.	
3. All members are required to pay a one-time \$	100 nonrefundable initial fee.	
4. Membership Options:		
Pay a \$63.50 monthly fee and work 16 hou	urs each month as a sales clerk in the Gallery.	
Pay a \$113.50 monthly fee and do not wo	rk in the Gallery.	
5. Attend monthly meetings.		

- 6. Provide a variety of artwork and refresh work bi-monthly.
- 7. Assist with at least 2 special events per year and/or volunteer for another job (to be determined by Administrative Committee).
- 8. Present samples of work and artist's statement to ArtForms Gallery LLC membership to be juried upon application.
- 9. Jury new artwork if in a different medium or significantly different style.
- 10. Prepare inventory sheet and inventory materials consistent with ArtForms Gallery LLC standards. Inventory must be done monthly.
- 11. Artist is required to provide a 60 day written notice to the Administrative Committee before resigning. All bills are to be paid before leaving, including the rent for those 60 days. Any unpaid bills will be deducted from the final check/deposit. If the final deposit does not cover the unpaid amount, legal means may be used to collect payment of the remainder owed by the artist.
- 12. Carry out at least one major duty to help with the functioning of the CO-OP. For instance: work calendar, inventory of supplies, show schedule, community event planning, customer list, janitorial work...etc.
- 13. All volunteer work other than the above is most welcomed!
- 14. Complete and sign the secondary Facilities Use Agreement if using an off-site location for an ArtForms-sponsored workshop.

Insurance: All artists are responsible for theft and damage insurance for their own art work. ArtForms Gallery LLC is not responsible for damage or theft of any member's artwork.
